

Anders Behring Breivik at his probation audience at Skien Prison, Norway on January 19. The audience revived memories of the massacre and showed the extremist views of the Norway Neo-Nazi strip. Tuesday by a Norwegian court that he said that he "appeared devoid of empathy and compassion for the life of terror." Breivik, 42 years old, who has completed 10 years of a sentence of 21 years for the attacks, showed no signs that his extremist opinions had decreased during his imprisonment. When he began the probation hearing on January 18, he entered the courtroom and made a Nazi -style greeting. He also wore and used signs stamped with racist messages, including one that decided to "put his genocide against our white nations." Speaking to the judge, Mr. Breivik demanded that he be treated as a war prisoner. Bjorvik supervised the probation hearing, which lasts two weeks and was held in Skien's prison for security reasons. Breivik's lawyer, Oystein Storrvik, said Tuesday that they would appeal the verdict, after expressing pessimism at the beginning of the audience. "No Norwegian lawyer wants a case to start with Hitler's greeting," he said in an interview with The Times last month. He said he was not particularly concerned with Mr. Breivik winning his probation, and added that his strategy in the long term was "to boost the conditions under which he is sitting" in prison. On July 22, 2011, Mr. Breivik detonated a fertilizer bomb in the center of Oslo, killing eight people. He then triggered in a summer camp on the island of Utoya, killing 69 people, most of them teenagers. The camp was organized by Youth arm of the Central Left Labor Party of the PAas. Those affected in Utoya were not children, but people with "leadership positions." The hearing, Hulda Karlsdottir, the main prosecutor, said that Mr. Breivik should remain in prison and that he "was dangerous after complying with his sentence." He added: "Banto the survivors and the relatives remain the same bottomless grief, and the atrocities committed have no parallel in Norwegian history. Breivik, who legally changed his name to Fjotolf Hansen in 2017, said he had carried out the attack on the att to the "" cultural suicide."
